



**64th Annual Business Meeting
Atlanta Sheraton
Atlanta, Georgia
February 22, 2011**

1. At, 10:50 a.m., President Tim Culhan called the meeting to order and announced that Bruce Cunningham had been appointed as Parliamentarian for the meeting.

2. Secretary Scott Dittman announced that minutes of the 2010 business meeting were published in the fall newsletter and on the SACRAO website, and that he had received no corrections. A motion was made and seconded to accept the minutes as published. Without correction, the minutes were approved by voice vote.
3. Treasurer Amy Bissette read a positive statement from SACRAO's external auditors. She called attention to the distributed Statement of Assets through December 31, 2010, and to the Proposed 2011 SACRAO Budget. The treasurer's report and 2011 proposed budget were approved by voice vote.
5. VP for States/Regionals and Memberships Deanna Adams thanked the first-timers orientation committee. 161 first-time attendees at the conference, 46 of whom attended the orientation session on Sunday. New institutional members include:

Kareema Cusack has joined as an associate member and NRCCUA and Tiland Software have joined as new corporate partners. Active membership now numbers just under 600 institutional members and approximately 3,200 individuals.

6. Past President Sallie Marchello reported for the Constitution and Bylaws Committee. The following five changes were proposed:

Constitution

Second Paragraph:

Article II. Purposes

"Specifically, the association shall promote and advance the improvement of academic records, admissions, data management, enrollment services, financial aid management, international education, and registration admissions, registration, records, data management, international education and financial aid management practices through study, education, and research; advance professional knowledge and techniques by fostering the exchange of experiences and information; and develop and advance standards of competence in the profession."

Section 1. Institutional Membership

Article III. Membership and Voting

"Institutional membership shall be open to employees of any collegiate institution located in the states of Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, Oklahoma, South Carolina, Tennessee, Texas, or Virginia, as well as the Commonwealth of Puerto Rico. The employees should have job responsibility in at least one of the following areas: academic records, admissions, data management, enrollment services, financial aid management, international education, and registration. ..."

Article IV. Executive Committee Duties, Responsibilities and Elections

Section 1. Executive Committee

"The Executive Committee shall be composed of eleven officers, two Members-at-Large, the Newsletter Editor and the Chair of the Local Arrangements Committee for the Annual Meeting. Executive Committee members must be institutional members of the association. ..."

Bylaws

Section 1.

Article IV. Committees and Appointments

"A five member Nominations and Elections Committee shall be elected by the membership. N&E Committee members must be institutional members of the association. ... Except for the Chair-Elect, no member shall be eligible to serve again on the Nominations and Elections Committee until ~~three~~ five years have elapsed from the end of the year's service. This same provision shall apply to the Chair-Elect after serving as Chair."

The report, including the recommended changes to the Constitution and Bylaws, was approved unanimously by voice vote.

Past President Marchello also reported on site selections for future SACRAO Conferences.

- SACRAO 2012: Northern Kentucky. Kim Taylor will serve as LAC Chair.
- SACRAO 2013: San Antonio, Texas.
- SACRAO 2014: the conference will be held somewhere in the Carolinas.
- SACRAO 2015: Alabama and Mississippi have been solicited to submit bids.

All SACRAO Past Presidents were asked to meet immediately following this meeting for a photograph.

7. The chair of the 2010-2011 Nominations and Elections Committee, Janet Davis, reported the following.

The 2010-11 Nominations and Elections Committee met October 1-3, 2010, in Raleigh, NC, at the Residence Inn Crabtree Valley. The N&E Committee make-up (three from the Carolinas) made Raleigh a good location for the meeting. It is large enough to have reasonable air service and lower fares. The Residence Inn provided comfortable suite accommodations, with enough space in the chair's suite for meetings. It includes breakfast with the rooms, so the committee did not have any meal costs for breakfast. In keeping with the trend begun in 2009, the committee opted to dine in local restaurants and, with Louis' guidance, enjoyed very good meals well under the per diem meal limit.

Our nominations came from nine states. Arkansas, Florida, Oklahoma and North Carolina provided no nominations. (Although we have nominees from North Carolina and Oklahoma, they came from elsewhere.). Twenty-seven different SACRAO members were nominated, some with more than one nomination for a particular position or nominations for multiple positions.
